Sec. 18-1. Posting of temporary signs, posters and advertisements; penalty for violation.

(a) *Prohibition.* Any individual, whether acting on his own behalf or representing a larger group or organization, who posts or affixes any variety of temporary signs, posters, or advertising within the corporate limits of the village, shall have complete responsibility, for the timely and complete removal and disposal of such signs, posters or advertisements. If such items are not completely removed and properly disposed of within three days following the completion of any and all events to which such advertisements pertain, the individual originally responsible for affixing such items shall be in violation of this section.

(b) *Municipal civil infraction.* Any person who violates any provision of this section shall be responsible for a civil infraction, subject to payment of a civil fine as set forth in section 22-38. Repeat offenses under this article shall be subject to increased fines as set forth in section 22-38.

ARTICLE I. IN GENERAL**Sec. 18-1. Posting of temporary signs, posters and advertisements; penalty for violation.**
